





### ELECOM'S SHARE SALES

The Ethiopian Capital Market Authority (ECMA) has revealed plans to proceed with the sale of ten percent shares of Ethio Telecom before the finalization of public offerings and trading of securities directive, marking significant milestone in the country's economic landscape.

According to ECMA, the draft directive for public offerings was made available for public feedback for the second time on Friday. As the regulatory body overseeing the primary share market and the forthcoming secondary market, ECMA aims to facilitate the smooth transition of Ethio Telecom's shares to the

general public.

### **EU considers ban on Ethiopian flowers** amid FCM concerns

Ethiopia's flower industry, the second largest foreign exchange earner after coffee, is at risk of suffering significant setbacks due to the presence of the False Codling Moth (FCM). According to recent data, the sector was projected to earn \$600 million USD from exported flower products in the 2022/23 fiscal year. Notably, Ethiopia, along with Kenya, Ecuador, Vietnam, and the Netherlands, is a major supplier of flower products to the European market.

The European Union Plant Health Unit of DG Sante has made a decision requiring stringent procedures for flower products from European Union countries due to the potential introduction of the FCM, a destructive pest. The Ethiopian Agriculture Authority has acknowledged that the FCM is already prevalent in the country. However, when the pest is transported to European countries, changes in environmental conditions can cause it to become a disease, exacerbating the problem.

Experts in the field emphasize that eradicating the FCM from Ethiopia is a challenging task that demands immediate attention. In response, the Ethiopian Agricultural Authority has initiated discussions with horticulture producer exporters to explore potential solutions and administrative measures.

Unfortunately, a recent report from the European Union, which receives 85 to 90 percent of Ethiopia's

flower production, highlights the significant challenges that lie ahead. The European Food Safety Authority (EFSA) has issued a report regarding the presence of the FCM on flowers since 2018. As a consequence, European countries have warned that imports of flower products from Ethiopia will be halted unless they receive confirmation that the goods are free from FCM.

### A new African alliance is starting a revolution in the continent's geopolitics

or many centuries, Africa has been a theater for atrocious operations, mainly devised and implemented by the Western powers. These terror operations always have the same specific goal: looting African human, natural, and cultural resources for the economic, cultural and political hegemony of the West.

In the 16th century, the first great systemic criminal attack the Western powers launched against Africa was the organization of the black slave trade. By deciding that black skin was a good criterion for discriminating between freeman and slave throughout the globe, the Western powers created a prism for viewing humanity though absolutely absurd and insane biological concepts. Walter Rodney explains it very clearly in his essay How Europe Underdeveloped Africa, published in 1972.

In the early 19th century, Africa had to fend off the same Western powers in a second massive attack, after their first capitalist accumulation, by enslaving millions of African people, had been accomplished. The colonial invasion of Africa by France, Britain, Portugal, Spain, Italy, Germany, the Netherlands and Belgium became a massive era of crimes against humanity.

After the Africans succeeded in their struggle against colonial occupation during the 20th century, notably with the help of the Eastern Block led by the USSR and China, a third attack was launched against Africa: a fake decolonization process which occurred in the former French colonies. On the one hand, French President Charles De Gaulle, who liberated his country from Nazi domination with the help of African colonial troops, formally acknowledged African independence. On the other hand, the same Monsieur De Gaulle organized a neocolonial system by keeping French troops in Africa. French West Africa was divided into fifteen countries, and control was maintained by the French central bank in fifteen African economies through the CFA franc, a colonial currency. France supported the worst African dictators as the heads of those states, and controlled African ideas through the Francophonie system of values and media.

#### Libyan trace

The birth of ECOWAS (the Economic Community of West African States) on May 28, 1975 occurred in that context of continued domination. While the UK was reorganizing its hegemony in Africa through the Commonwealth system, France was creating the system of Françafrique, a mafia of French and African political élites which targeted the rights and the lives of the African people. Two of the main creators of ECOWAS in 1975, General Yakubu Gowon of Nigeria and General Gnassingbe Eyadema of Togo, were putschists under Anglo-American and French control. De facto, ECOWAS was created under the big Western alliance, NATO. All the NATO powers continue to have their hands in ECOWAS affairs today, one way or another. The principles and rules of the ECOWAS' charter have never been seriously respected by its members, especially those who participate in in its highest decision-making body, the Conference of the heads of states.

Here is an example to illustrate the obvious weakness of ECOWAS. When Libya was attacked in 2011 by NATO, which led to the actual takeover of the country by the terrorist forces of Al-Qaida and ISIS, no African political organization considered the attack an infringement on African sovereignty. Even better, many African ECOWAS and African Union (AU) leaders supported the West and NATO, and repeated NATO's false narrative concerning Muammar Gaddafi's regime. They pretended Gaddafi was executing his own people, and thus justified the NATO aggression. Their attack against Africa was led by the USA under Barack Obama, the United Kingdom under David Cameron and France under Nicolas Sarkozy. How can one understand that some African governments could later accept the so-called help of the same country to fight terrorism in Africa? How can Africa accept cooperation in the struggle against terrorism with the West's pyromaniac firefighters?

continued to cooperate with NATO in the AU and in ECOWAS, while clearly knowing that NATO was deeply involved in the destabilization of the entire African continent. **Main principles of the Alliance of Sahel States** 

Malian leader Assimi Goita, Burkinabe leader Ibrahim Traoré and Nigerien leader Abdourahamane Tchiani are the three inheritors of the pan-Africanist ideology in Africa today. Their political engagement is inspirated by the works of the greatest African thinkers, including Kwame Nkrumah, Amilcar Cabral, Marcus Garvey, Franz Fanon, Cheikh Anta Diop, Theophile Obenga, and many others. These leaders believe that there is no hope for the people of Africa unless they secure African sovereignty first and then act to fulfil this precise vision of Africa's destiny.

This is why the creation of the Alliance of Sahel States on September 16, 2023, is a real revolution in African geopolitics. Mali, Burkina Faso and Niger have decided to rebuild the interaction in West Africa on radically different principles. First of all, the three leaders came to the oath through revolutionary and internal political processes in their countries. Their legitimacy is not an external one, but the result of an endogenous movement of their people. In Mali, leader Assimi Goita appeared at the top of the state after a long struggle between civil political society and Ibrahim Boubacar Keita's regime. Keita's system was fought by the Malian people for its corruption, its dependence to French and Western neocolonialism, and its inability to overcome terrorism. In Burkina Faso and in Niger, the regimes of Roch Christian Kabore and Mohamed Bazoum were confronted by the civil societies for the same reasons. This resistance process of the West African people got inside the armies, and so patriotic, revolutionary and pan-Africanist forces emerged at the same time in all the bodies of these African societies.

The Alliance is set to establish new West African geopolitics based on three principles: sovereignty, freedom of choice of strategic partners among the world's powers, and defense of African peoples' vital interests. Sovereignty is impossible without the security of those who decide. So, the reconquest of the three countries' territories by their armies is a crucial priority. At the same time, sovereignty means accountability of the leaders of each country to the only sovereign, the people.

The diversification of partnership means the countries will not fight against terrorism in Africa while cooperating on the field of war with the Western powers. That is why the Alliance is deeply involved in military, diplomatic, and economic cooperation with the greatest powers of the Global South, or the Multipolar World. Clearly, the destiny of the Alliance is to be involved in the dynamical construction of the BRICS, avoiding the supremacy of the dollar and the euro.

Finally, the Alliance is fully engaged with the internal dialog between the leaders and the people of Mali, Burkina Faso and Niger. That is why the Alliance is self-financed and works hard to secure economic and cultural cooperation, as well as political integration as a confederation of states.

When ECOWAS threatened to attack Niger for the defense of illegitimate French control of the country's strategic uranium resources. Mali and Burkina Faso stood up in unison to defend their Nigerien neighbor. They clearly understood that the threats facing Niger are the same, rooted in the slave trade and colonial aggression, as well as Western neocolonial occupation, for many centuries now. It is that deep memory of the shared tragedy of African history that constitutes the cement of the new African sunrise of conscientiousness and justice. The difference between ECOWAS and the Alliance of the Sahel States is obvious. While the first has many times shown its dependence on Western interests and powers, the latter is working openly for a sovereign and powerful Africa, free in its minds, free in its hands, and able to shape the renewal of hope among all African nations. We need, at the same time, to have a look in our own mirror. The most difficult part of the African Struggle in the 21st century, is to recover African genius through a critical memory of ourselves, and to keep our eyes open with a lot of lucidity to understand the reality of the game of this world's powers.

### URGENT CALL TO ADDRESS HUMANITARIAN CRISIS IN TIGRAY AS HUNGER AND DISPLACEMENT PERSIST

In a recent report titled "Scars of War and Deprivation: An Urgent Call to Reverse Tigray's Humanitarian Crisis," alarming details have emerged regarding the ongoing crisis in the Tigray region of Ethiopia. The report highlights the dire situation faced by the population, urging immediate action to address the escalating humanitarian crisis.

Despite the declaration of peace between the Federal Ethiopia Government and Tigray authorities over a year ago, the region continues to grapple with widespread hunger and displacement. The combination of a two-year-long siege during the war, a severe drought, and a suspension of food aid to combat corruption has plunged many into a state of crisis. Vulnerable groups, including mothers who have survived gang rape, are now left wondering how they will feed their children instead of receiving the necessary physical and mental healing they require.

The conflict in Tigray, which began in November 2020, has resulted in an estimated death toll of over 600,000 people and the displacement of nearly 3 million. Human rights violations and sexual violence have left lasting scars on the population. Despite the cessation of hostilities agreement, Eritrean troops, Amhara forces, and other armed groups have yet to fully withdraw from western and southern parts of Tigray, hindering the return of displaced individuals to their homes.

Adding to the crisis, in 2023, the United States government temporarily paused its food assistance program due to widespread corruption and aid diversion by Ethiopian government and regional officials. While the decision aimed to address these issues, it exacerbated the already catastrophic situation for millions of Ethiopians who rely on food aid. Although food assistance has gradually resumed, it is unable to keep pace with the growing hunger, with reports indicating that only 14 percent of the targeted population had received aid by January 2024, and child malnutrition rates reaching 26.5 percent.

The most vulnerable groups affected by the food shortages are Tigray's internally displaced people, particularly women, children, and the elderly. Families are resorting to feeding on cattle roots, and children are forced to sleep longer to alleviate hunger pangs. Chronic undernutrition, reflected in high levels of stunting and malnourished pregnant and lactating women, has become prevalent, with 60 percent of households experiencing moderate or severe hunger.

During a recent visit to the region, Refugees International found that women bore the brunt of the crisis, grappling with hunger, sexual violence, and displacement simultaneously. Many displaced households are led by women, as male family members were killed or remain missing. While some victims of sexual violence can access treatment, damaged or non-operational health facilities and limited resources hinder their recovery. The overlapping challenges of unaddressed sexual violence, worsening hunger, and displacement pose significant risks to the well-being and recovery of IDP women in Tigray.

The report emphasizes the responsibility of the Ethiopian government to protect its population, ensure access to basic rights, and uphold commitments made in the peace agreement. It calls for peace to be maintained, the withdrawal of armed groups from Tigray, and the restoration of essential services and infrastructure. Furthermore, it urges the international community to increase its response and support for Tigray, emphasizing the need for increased aid, accountability for atrocities, and the inclusion of local actors in relief efforts.

# Ethiopia launches humanitarian response plan to address growing crisis



### ECMA paves way ...

This move is part of the government's broader strategy to open up key sectors to private investment and enhance market competitiveness.

Recent discussions led by Ethiopian Investment Holdings (EIH), chaired by Prime Minister Abiy Ahmed and comprising current and former government officials and experts, assessed ECMA's progress in preparing the market and the readiness of Ethio Telecom for share sales. PM Abiy Ahmed emphasized the government's commitment to privatize 10 percent of Ethio Telecom's shares, enabling Ethiopian citizens to participate in the ownership of the national telecommunications company.

Agriculture Authority, expressed concern that this decision could have devastating consequences for the country's flower industry. Although there are approximately 50 players in Ethiopia's flower industry, FCM has been detected on seven farm stations, resulting in the quarantine of those facilities in European countries.

In recent years, shipments of roses from Ethiopia to Europe have been intercepted due to the presence of FCM. European regulations dictate that the detection of a single living FCM at any stage of development within Continued from page

a shipment leads to the rejection of the entire consignment. FCM is included on the European Commission's list of harmful organisms recommended for regulation as quarantine pests to prevent its introduction into Europe, where it poses a threat to various outdoor and glasshouse crops.



### World Bank report urges Ethiopia to accelerate structural reforms

In a recently released report by the World Bank, titled Country Climate and Development Report (CCDR), it is stated that Ethiopia's transition to a market economy has been hindered, and its external competitiveness has been undermined by a state-led growth model that heavily relied on imports and public investments. The growth model was characterized by pervasive price distortions and an overvalued exchange rate.

The report emphasizes the need for the government to expedite structural reforms to build a climate resilient economy. Ethiopia has been grappling with significant macroeconomic imbalances, financing challenges, a depletion of external reserve buffers, foreign exchange shortages, a growing parallel market premium, and high inflation. Failure to address these issues in a timely manner could lead to an increase in poverty exacerbated by the effects of climate change. The report highlights that efforts to reduce poverty are being impeded by compounding shocks from conflicts, droughts, and rising food prices.

The emergence of the capital market is identified as a crucial step toward developing a climate-change-mitigating economy. The report, released on February 27, indicates that Ethiopia needs to allocate at least USD 27.6 billion over the next 25 years to tackle climate change challenges effectively.

The research suggests that structural changes and macroeconomic stabilization will not only enhance climate resilience but also promote economic growth. It states, "Ethiopia's current economic situation features serious macroeconomic imbalances, few jobs, and widespread poverty, insecurity, and vulnerability. Without addressing the causes of these problems through a program of macroeconomic stabilization and structural reforms, it will be difficult to undertake actions to build climate resilience." Implementing these reforms will also help propel the stalled structural transformation of the Ethiopian economy and its transition to a market economy, contributing to inclusive growth and poverty reduction.

The report emphasizes the essential role of the private sector in addressing these challenges. It notes that climate investment needs are significant, considering the resource shortages.

The CCDR estimates that sector-specific climate investments, focusing on agriculture, livestock, sustainable land management, urban infrastructure, roads and bridges, and water storage, will amount to USD 27.6 billion by 2050. This represents 3.6 percent of cumulative GDP until 2050, with frontloading of investments necessary to protect against the worst impacts of climate change.

While acknowledging the difficulty in fully ascertaining the volumes of climate finance mobilized by Ethiopia, the report estimates that it ranges from USD 0.6 to 3.2 billion per year, with indications of a decline. The report suggests that in the near term, mobilizing more domestic resources and unlocking access to grant and concessional resources through structural reforms should be a priority.

The report also highlights the importance of grant and concessional finance as the most significant and least expensive source of external finance for climate-related purposes. It recommends that Ethiopia implement stronger policies to support performancebased allocation (PBA) formulas, which will determine resource envelopes from multilateral institutions. Additionally, financial sector reforms are crucial to improve stability and depth, strengthen regulatory frameworks, and address the relationship between stateowned enterprises (SOEs) and state-owned banks. Opening the banking sector to foreign investment, establishing deposit insurance, and increasing insurance market penetration are also key areas for reform. Developing capital markets will further facilitate the issuance and exchange of climate finance instruments such as green bonds, supporting private capital mobilization in the medium term.

The report concludes by emphasizing the need to reform Ethiopia's social safety net programs to effectively respond to climate shocks and strengthen adaptive capacity, with a priority on the lowlands.

As Ethiopia tackles the challenges of climate change and seeks to build a resilient economy, it is crucial for the government to implement the recommended structural reforms, mobilize resources, and engage the private sector to achieve sustainable and inclusive growth while addressing poverty and vulnerability.

The CCDR aims to support Ethiopia in achieving its development goals while navigating the challenges posed by climate

change until 2050. Modeling analysis conducted for the CCDR reveals that climate change will impose substantial costs on the economy, with costs increasing rapidly after 2030.

The report identifies several channels through which the adverse impacts of climate change will materialize. These include more frequent and severe flooding, reduced crop and livestock yields, variable hydropower production, infrastructure damage, and losses in human health and productivity.

If Ethiopia maintains its current policies, characterized by a significant state presence in the economy and slow progress on structural reforms, known as the constrained growth (CG) scenario, the report projects average annual losses to GDP and household consumption ranging from 1 to 1.5 percent annually in the period of 2024-2030. These losses are expected to reach the upper end of the range in a dry and hot climate scenario.


Furthermore, the report highlights that impacts will rapidly increase from 2030 onwards, with average deviations from GDP and household consumption reaching as high as 5 percent during the 2040s. The cumulative economic loss is projected to rise from about 10 to 14 percent of 2022 GDP between 2023-2030, to approximately 20 to 30 percent of average decadal GDP between 2030-2040, and even higher thereafter.

"If current policies are maintained, poverty will also increase due to the impacts of climate change in the absence of macroeconomic and structural reforms," the report warns. Analysis conducted for the CCDR demonstrates that climate change will lead to larger increases in poverty over the next 25 years without the implementation of structural reforms. Under the CG scenario, poverty is projected to increase by 0.5 to 1.7 percentage points by 2050. However, with the implementation of structural reforms, the increase in poverty would be much smaller, ranging between 0.1 to 1 percent.

The report argues that undertaking macroeconomic stabilization and structural reforms will mitigate the adverse impacts of climate change on economic growth. It emphasizes that structural reforms will enhance resilience and reduce the cost of adapting to climate change. The agriculture sector is highlighted as an example, where implementing reforms would lead to a significant increase in agricultural output, even in the face of climate change. This would result in an excess production that surpasses domestic demand by the end of the decade, generating a substantial marketable/ exportable surplus from 2030 onwards.

However, the report cautions that structural reforms alone will not be sufficient. Additional measures will be required to adapt, including a shift away from a center, state-driven development approach. These measures encompass additional policies and incremental investments aimed not only at increasing productivity but also at reducing the costs associated with climate change impacts.

As Ethiopia grapples with the challenges posed by climate change, the report underscores the importance of implementing structural reforms and additional measures to build resilience, adapt effectively, and mitigate the adverse effects on economic growth and poverty levels.



### ESX nears full capitalization to launch operations

The Ethiopian Securities Exchange (ESX) has announced that it has secured over 95 percent of the required capital to officially commence its operations, marking a significant milestone in the development of the country's capital market. According to the regulations governing the capital market in Ethiopia, ESX revealed that it has successfully raised the necessary capital to establish a centralized stock exchange. With a targeted capitalization of 1 billion birr, ESX is poised to begin operations in the near future. Over 20 financial institutions have been invited to become shareholders of ESX as part of the initiative to establish Ethiopia's investment market. However, specific details regarding the number of institutions that have made purchases and the total amount of funds raised have not been disclosed.

ESX experienced a significant influx of investments, with Awash and Global Bank injecting a combined total of 127 million birr within a week. Awash Bank emerged as the top investor, purchasing shares worth 70 million birr, while Global Bank contributed 50 million birr to ESX's capitalization efforts. As per the regulations governing the establishment of the capital market, ESX operates as a share company, with financial institutions being prioritized as key stakeholders in the stock market. Private banks such as Zemen Bank, Singe Bank, and Global Bank have continued to demonstrate their confidence in the ESX market, collectively investing millions of birr to support its launch.

Tilahun Esmael, PhD, CEO of ESX, disclosed that the recent acquisition of a 50 million birr investment from Global Bank has significantly bolstered the exchange's capital base. Despite the ongoing capital-raising period expected to conclude by March 2, 2024, ESX has already surpassed the 95 percent mark.

"We have fulfilled our capital-raising objectives ahead of schedule," stated Tilahun Esmael. "While the final subscription forms are yet to be received, we have secured commitments from investors that exceed our initial expectations." The establishment of ESX holds the potential to accelerate economic growth in Ethiopia by providing individuals with opportunities to generate income through ownership, management, or transfer of investment assets in the capital market system.


### Airstrike in Ethiopia's Amhara Kills at Least 15 Civilians, Residents Say

The strike took place on [last] Monday around 24 km (15 miles) from where Ethiopian troops were fighting militiamen, according to the residents who asked not to be named for fear of reprisals. Some of the victims were fleeing the clashes, while others were returning home from a baptism ceremony, they said ... "We first heard an explosion and the area was covered with smoke and dust," a priest said. "We collected 15 bodies. It was more a matter of collecting their dismembered bodies. Hands, legs and heads were everywhere"...The Ethiopian military has used drones extensively during the fighting, according to the state-appointed Ethiopian Human Rights Commission (EHRC).

Ethiopian Airlines Boss Calls for African Aviation Deregulation to Lower Costs for Travellers

The head of Africa's largest carrier Ethiopian Airlines has called for the continent to implement an agreement allowing airlines to operate freely to increase competition and reduce the costs for travellers amid rising demand for flying. It is "a big obstacle" for Ethiopian Airlines and affects "nearly all African airlines" who are not able to expand their services, Ethiopian Airlines Group chief executive Mesfin Tasew told the Financial Times. An African initiative to liberalise the aviation space to which 37 countries have signed up was launched in 2018. However, the Single African Air Transport Market has not yet been fully implemented, in part due to countries protecting their national carriers. Unlike in other regions that have deregulated aviation, airlines operating in Africa have to sign bilateral agreements to fly between two countries on the continent.






### The Rise of Modern Day Socialists

Throughout most of American history, the idea of socialism has been a hopeless, often vaguely defined dream. So distant were its prospects at midcentury that the best definition Irving Howe and Lewis Coser, editors of the socialist periodical Dissent, could come up with in 1954 was this: "Socialism is the name of our desire."

That may be changing. Public support for socialism is growing. Self-identified socialists like Bernie Sanders, Alexandria Ocasio-Cortez and Rashida Tlaib are making inroads into the Democratic Party, which the political analyst Kevin Phillips once called the 'second-most enthusiastic capitalist party" in the world. Membership in the Democratic Socialists of America, the largest socialist organization in the country, is skyrocketing, especially among young people.

What explains this irruption? And what do we mean, in 2024, when we talk about "socialism"? Some part of the story is pure accident. Corey Robin, Professor of Political Science at Brooklyn College and the City University of New York Graduate Center stated that in 2016, Mr. Sanders made a strong bid for the Democratic presidential nomination. Far from hurting his candidacy, the "socialism" label helped it. Mr. Sanders wasn't a liberal, a progressive or even a Democrat. He was untainted by all the words and ways of politics as usual. Ironically, the fact that socialism was so long in exile now shields it from the toxic familiarities of American politics.

Another part of the story is less accidental. Corey Robin noted that since the 1970s, American liberals have taken a right turn on the economy. They used to champion workers and unions, high taxes, redistribution, regulation and public services. Now they lionize billionaires like Bill Gates and Mark Zuckerberg, deregulate wherever possible, steer clear of unions except at election time and at least until recently, fight over how much to cut most people's taxes.

Liberals, of course, argue that they are merely using market-friendly tools like tax cuts and deregulation to achieve things like equitable growth, expanded health care and social justice which are the same ends they always have pursued. Kevin Kelly of Wired Magazine explained that for decades, leftleaning voters have gone along with that answer, even if they didn't like the results, for lack of an alternative.

Socialism means different things to different people. For some, it conjures the Soviet Union and the gulag. For others, Scandinavia and guaranteed income. But neither is the true vision of socialism. What the socialist seeks is freedom.

John Altman, an American analyst argued that of under capitalism, people are forced to enter the market just to live. The libertarian sees the market as synonymous with freedom. But socialists hear "the market" and think of the anxious parent, desperate not to offend the insurance representative on the phone, lest he decree that the policy she paid for doesn't cover her child's appendectomy. According to Kevin Kelly, under capitalism, people are forced to submit to the boss. Terrified of getting on his bad side, people bow and scrape, flatter and flirt, or worse just to get that raise or make sure they don't get fired.

John Altman further noted that the socialist argument against capitalism isn't that it makes people poor. It's that it makes people unfree. When our well-being depends upon their whim, when the basic needs of life compel submission to the market and subjugation at work, we live not in freedom but in domination. Socialists want to end that domination: to establish freedom from rule by the boss, from the need to smile for the sake of a sale, from the obligation to sell for

#### the sake of survival.

Listen to today's socialists, and we will hear less the language of poverty than of power. They invokes the 1 percent and speaks to and for the "working class", not "working people" or "working families," homey phrases meant to soften and soothe. The 1 percent and the working class are not economic descriptors. They're political accusations. They split society in two, declaring one side the illegitimate ruler of the other; one side the taker of the other's freedom, power and promise.

Kenny Malone, economic analyst of Planet Money stated that like the great transformative presidents, today's socialist candidates reach beyond the parties to target a malignant social form: for Abraham Lincoln, it was the slavocracy; for Franklin Roosevelt, it was the economic royalists. According to Kenny Malone, the great realigners understood that any transformation of society requires a confrontation not just with the opposition but also with the political economy that underpins both parties. For Lincoln in the 1850s confronting the Whigs and the Democrats, that language was free labor. For leftists in the 2010s, confronting the Republicans and the Democrats, it's socialism.

To critics in the mainstream and further to the left, that language can seem slippery. With their talk of Medicare for All or increasing the minimum wage, these socialist candidates sound like New Deal or Great Society liberals. There's not much discussion, yet, of classic socialist tenets like worker control or collective ownership of the means of production.

And of course, there's overlap between what liberals and socialists call for. But even if liberals come to support single-payer health care, free college, more unions and higher wages, the divide between the two will remain. Danielle Kurtzleben, another economic analyst of Planet Money explained that for liberals, these are policies to alleviate economic misery. For socialists, these are measures of emancipation, liberating men and women from the tyranny of the market and autocracy at work. Back in the 1930s, it was said that liberalism was freedom plus groceries. The socialist, by contrast, believes that making things free makes people free.

According to Danielle Kurtzleben, it's also important to remember that the traffic between socialism and liberalism has always been wide. The 10-point program of Marx and Engels's "Communist Manifesto" included demands that are now boilerplate: universal public education, abolition of child labor and a progressive income tax. It can take a lot of socialists to get a little liberalism: It was socialists in Europe, after all, who won the right to vote, freedom of speech and parliamentary democracy. Given how timid and tepid American liberalism has become, it's not surprising that a more arresting term helps get the conversation going. Sometimes nudges need a nudge.

Still, today's socialism is just getting started. It took Lincoln a decade plus a civil war, and the decision of black slaves to defy their masters, rushing to join advancing Union troops to come to the position that free labor meant immediate abolition.

In magazines and on websites, in reading groups and party chapters, socialists are debating the next steps: state ownership of certain industries, worker councils and economic cooperatives, sovereign wealth funds. Once upon a time, such conversations were the subject of academic satire and science fiction. Now they're getting out the vote and driving campaigns. It's too soon to tell whether they'll spill over into Congress, but events have a way of converting barroom chatter into legislative debate.

As Corey Robin noted, socialism is not journalists, intellectuals or politicians armed with a policy agenda. As Marx and Engels understood, this was one of their core insights, what distinguished them from other socialist thinkers, ever ready with their blueprints, it is workers who get us there, who decide what and where "there" is. That, too, is a kind of freedom. Socialist freedom.

have the privilege to travel abroad quite frequently and every time I visit another country, my eyes are opened to the way things are done there. At the same time, I can't help but compare what I see with the way we do things here.

I recently visited an Asian country and took the opportunity to make a tour with a guide. Normally I travel around making my own bookings and planning my own visits but this time I wanted to take a more relaxed approach and leave all the planning and logistics to somebody who knows his or her ways around. And it paid off. Admittedly, when you first meet the person, you will depend on during the next few days, it takes some time to get used to a new accent develop a common understanding and clarify expectations. In the course of the first day my initial apprehension changed into acceptance as we went underway, and I noticed his safe driving style and a keen interest in what I wanted to see and learn during this trip. Over the next few days, it turned out to become a wonderful experience, during which I felt safe, understood, and given real value for money. Things change though, from the moment the visitors are picked up from the airport, introduced to the office and offered the first Ethiopian coffee and lunch. Hospitality after all is one of our great assets! Next comes the actual project visit, travelling by air and road, during which the visitors, become dependent on us, the project team, and the communities we are working with. The team will be friendly, caring and solving problems all the way, making the visit as comfortable as possible. Back in the main office in the city, feedback from the visitors often included appreciation for the way all was organised, their wellbeing taken care of and the capacity of the team to carry out their work. Now the situation on the ground and the challenges faced were understood. The visit turned out a real eye opener so to speak. Also here, bidding farewell, is filled with emotions.

has become quite challenging and families find it difficult to make ends meet. Choices must be made.

So, it is understandable to be discouraged and to be negative about many issues. I must admit that as I was returning to the country last week, I was apprehensive about a number of things that I knew were going to come my way. But as I approached immigration, I was welcomed back with a smile, and going down the stairs, our luggage was already on the belt. We were on our way home in the country of thirteen months of sunshine! At home we were greeted by typical Ethiopian breakfast dishes, we had missed for a while.

As the week began, I knew I had to renew my driving license and I dreaded going through that process. After all, two years ago, this was a very cumbersome and timeconsuming undertaking. After getting my medical report from the neighbourhood medical clinic in the morning, I went to the road authority office in the afternoon, where I was told that they did not take on new cases in the afternoon and that I should come back early next day. My apprehension was confirmed, and my heart already sank on my way to the licensing office early next morning. I arrived at 8am and I was surprised there were hardly any other customers. I got my service number and noticed there were only five others before me. Before too long it was my turn and I was served at the window, made my payment, and was advised to sit and wait. I sat down next to an Ethiopian gentleman, and we started a casual conversation. It turned out he had the same worries as me, remembering the process of two years ago, and he made sure he turned up at 7am to queue. He said he must have been even more worried than me as he was there much earlier. We had a laugh; his name was called, and he took off happily with his renewed license. Mine followed minutes later and I was back on the street within half an hour!

Now, I realise that these are only a few small positive experiences, that do not weigh out major challenges that many face, but still. Celebrating positive experiences really help compensate some of the discouraging issues that come our way. So let us look for the positive things in life. And as I mentioned earlier, there are many. The Ethiopian hospitality, culture, food, nature, the greatest coffee in the world, young new talents, and musicians. Watch and listen for example to Yohana Sahle on YouTube, to mention one. There is a whole generation of young people ready to make their footprint in society. Let us celebrate

n an exclusive interview with Víctor Treviño Escudero, the Ambassador of Mexico, conducted by Capital's Groum Abate, we delve into the dynamic landscape of diplomatic relations between Mexico and Ethiopia. As two nations with rich histories and vibrant cultures, their collaboration spans a spectrum of domains, from economic endeavors to cultural exchanges and collaborative ventures in agriculture, tourism, and infrastructure development.

Against the backdrop of global challenges, including the ramifications COVID-19 pandemic. the of Treviño Ambassador Escudero sheds light on the current state of diplomatic ties, emphasizing the resurgence of momentum in bilateral engagements post-pandemic. As both nations gear up to commemorate the 75th anniversary of their diplomatic relations, the interview offers a comprehensive overview of the shared aspirations and synergies driving their partnership forward.

burgeoning ties From economic facilitated by cargo flights and trade agreements to the promotion of cultural understanding through language programs and educational exchanges, Mexico and Ethiopia are charting new avenues of collaboration. The interview explores key initiatives in agriculture, tourism, renewable energy, infrastructure development, and underscoring the potential for mutually beneficial partnerships that transcend geographical boundaries.

Ambassador Treviño Escudero's insights provide a nuanced understanding of the multifaceted relationship between Mexico and Ethiopia, offering a glimpse into the transformative impact of diplomatic engagements on the socioeconomic landscapes of both nations. As they navigate the complexities of a rapidly evolving global landscape, Mexico and Ethiopia stand poised to harness the power of collaboration to propel their shared aspirations towards prosperity and sustainable development. ### Unveiling the bonds and opportunities between Mexico and Ethiopia

Capital: How would you characterize the current state of diplomatic ties between Mexico and Ethiopia, and what key areas of collaboration define the relationship?

Víctor Treviño Escudero: The current state of diplomatic ties between my country and Ethiopia is regaining impetus after the COVID-19 pandemic. We are expecting a visit to Mexico of a high-level delegation of the Diaspora Service of Ethiopia and there is a high possibility of a visit of the Mexican Foreign Minister, Alicia Barcena, in the upcoming months.

The momentum could not be better, as this year we celebrate 75th anniversary of the establishment of diplomatic relations between our countries.

trade (2020) amounted to \$5,641 USD, of which \$1,621 correspond to Mexican exports to Ethiopia and \$4,020 correspond to imports from that country, with a negative balance for Mexico of -\$2,399 dollars.

### Capital: In terms of cultural exchange, what initiatives or programs have been implemented to foster cultural understanding and collaboration between Mexico and Ethiopia?

Víctor Treviño Escudero: The pillars of our cultural exchange are language and education programs. The governments of Mexico and Ethiopia have established robust scholarship programs aimed at enhancing educational opportunities and fostering academic exchange between the two nations. One such initiative is the provision of Spanish language courses, facilitated by the Government of Mexico, which allows Ethiopian students and professionals to learn the Spanish language. Last year we donated a collection of books for children and Spanish learners to the Abrehot library, strengthening our presence and availability of reading material for those interested. Regarding scholarships and academic exchanges, the Mexican Diplomatic Academy offers specialized courses tailored for diplomats from Ethiopia, providing them with valuable insights into international relations, diplomacy, and negotiation skills. Furthermore, the scholarship programs encompass opportunities for Ethiopian students to pursue advanced degrees at renowned Mexican universities. Scholarships for Master's and Doctoral programs are available in various academic disciplines, enabling Ethiopian scholars to access high-quality education and research opportunities in Mexico.

diplomatic relations between our countries.

There's a strong foundation of mutual respect and interest in enhancing cooperation across various sectors, particularly in cultural exchanges or cooperation in international forums, especially regarding issues like climate change or sustainable development goals.

Capital: How would you describe the economic and trade relations between Mexico and Ethiopia? Are there any notable bilateral trade agreements or potential areas for future economic cooperation?

Víctor Treviño Escudero: The cargo flights operated by Ethiopian Airlines have greatly increased trade between the two nations, which opens significant business opportunities for Mexican companies looking to invest in Ethiopia. It's worth noting that Ethiopian Airlines is the first African airline to operate in Mexico and the first one to move to the recently built Felipe Ángeles International Airport in central Mexico.

The latest data in Trade Map indicates that bilateral

Cultural exchange programs facilitate the exchange of artists, musicians, dancers, and other cultural practitioners

between Mexico and Ethiopia. These exchanges allow artists to collaborate, share their skills and techniques, and create new works that reflect the fusion of their cultures. Cultural diplomacy events, organized by the Embassy, cultural institutions, and non-governmental organizations, promote cultural understanding and collaboration between Mexico and Ethiopia. These events may include film screenings, literary readings, art exhibitions, and cultural performances that celebrate the cultural heritage of both countries and promote intercultural dialogue.

### Capital: Mexico has a rich history in the field of agriculture. Are there any ongoing agricultural projects or initiatives in Ethiopia that involve collaboration between the two countries?

Víctor Treviño Escudero: Mexico is dedicated to assisting Ethiopia in combating the scale insect plague that harms cactus crops. As part of this commitment, Mexican agricultural technicians are training their Ethiopian counterparts to tackle this issue effectively. In Mexico, this pest has become an interesting source of income due to the high value pigment it creates. Cochineal, as we call it, has been present in our textiles, written texts and food industry for centuries.

Additionally, there's a cooperation agreement between Mexico's International Maize and Wheat Improvement Center (CIMMYT) and Ethiopia. Through this agreement, experts in agriculture receive training in development programs, which cover a wide range of topics, including agricultural entrepreneurship, market access, food safety standards, and agribusiness management. This collaboration aims to enhance Ethiopia's agricultural sector and promote sustainable development.

85% of the germplasm used in Ethiopian fields for wheat comes from CIMMYT, and the best practices shared with our experience in the Yaqui Valley, in Sonora, are of great importance to create drought-resistant crops and develop regions in Ethiopia that are not generally used for agriculture.

### Capital: Ethiopia is known for its diverse tourist attractions and historical sites. Has there been any cooperation between the two countries in the field of tourism, such as promoting bilateral tourism or sharing best practices in the tourism industry?

Víctor Treviño Escudero: We promote the tourist attractions of Mexico, as you know we have beach resorts, colonial cities, great nature attractions and of course Mexico City, the second city with the most museums in the world. With 170 museums and 43 galleries, the National Museum of History, the Chapultepec Castle, the Anthropology Museum, and the Templo Mayor Museum, are some of the most visited.

Mexico can offer collaboration in heritage conservation efforts, which could involve sharing expertise in preserving and managing historical sites, monuments, and archaeological treasures. Mexico's experience in heritage conservation and restoration could provide valuable insights for Ethiopia's efforts to safeguard its cultural heritage for future generations.

Mexico has also been committed to collaborating internationally to ensure that our cultural property is returned and to combat the sale and trafficking of Mexican cultural objects abroad. The restitution and protection of cultural property is a priority for Mexico, and we are happy to share with Ethiopia and the African Union our legal framework and experiences.

To that extent, we are working in showcasing some of the cultural expressions that are shared between both countries. We are committed with sharing the talent of

power. Collaborative efforts could focus on developing renewable energy projects and promoting sustainable energy solutions. This may involve joint research and development initiatives, technology transfer, capacity building, and investment partnerships to expand access to clean and affordable energy sources.

Collaboration could extend to the development of green infrastructure projects that promote environmental sustainability and climate resilience. This could include initiatives such as green building design, urban greening, sustainable water management, and ecosystem restoration projects that enhance resilience to climate change and contribute to biodiversity conservation.

### Capital: Mexico has a strong commitment to human rights and international development. How does the Embassy work to promote these values in Ethiopia, and are there any specific projects or initiatives aimed at supporting human rights and development in the country?

Víctor Treviño Escudero: Capacity building and training: The embassy may support capacity-building programs and training initiatives aimed at strengthening Ethiopian institutions and civil society organizations working in the areas of human rights, democracy, and good governance. This could include workshops, seminars, and technical assistance to enhance their ability to promote and protect human rights.

In recent years, we have partnered with NGOs to become "blue" every April and promote awareness of autism and promoting the right to education and protection of human rights of children in the spectrum. We have also shared our experiences in the process of becoming a feminist diplomacy. Together with UN Women, international organizations, NGOs and fellow embassies, we are committed to the #OrangeTheWorld campaign to end violence against women.

### Capital: Ethiopia plays a significant role in regional affairs, particularly in the Horn of Africa. How does Mexico view Ethiopia's role in regional stability and what are the prospects for enhanced cooperation in addressing regional challenges?

Víctor Treviño Escudero: Mexico follows with great interest the regional developments and the role of each country. We are following closely the recent agreements reached at the African Union Summit and look forward to work together in reaching joint goals.

Ethiopia's strategic location, large population, and growing economy give it considerable influence and responsibility in addressing regional challenges.

Stabilizing influence: Ethiopia's stability is crucial for

Víctor Treviño Escudero; Mexico and Ethiopia may coordinate their diplomatic efforts within UN bodies, including the General Assembly, Security Council, and specialized agencies. They may align their positions on key issues of mutual interest, such as human rights, sustainable development, peacekeeping, and international security.

In multilateral forums, Mexico and Ethiopia may support each other's resolutions, initiatives, and candidacies to advance shared priorities and interests. They may engage in voting blocs or coalitions with other like-minded countries to strengthen their influence and impact within the UN system.

Capital: Mexico has historically stood with Ethiopia during its challenging time of colonization, with notable support at the League of Nations. As a symbol of this friendship, Ethiopia named a roundabout "Mexico Square," although the monument no longer exists. Could you share your perspective on this historical connection and the significance it holds for the bilateral relationship between Mexico and Ethiopia today? And the fate of the monument?

Víctor Treviño Escudero: The historical connection between Mexico and Ethiopia, particularly during Ethiopia's challenging time of colonization, holds significant symbolic importance for the bilateral relationship between the two countries today. Mexico's solidarity and support for Ethiopia's sovereignty and independence at the League of Nations reflected a shared commitment to principles of self-determination, international law, and human rights.

The naming of a roundabout as "Mexico Square" in Ethiopia served as a tangible symbol of the friendship and solidarity between the two nations. It represented a gesture of gratitude and recognition for Mexico's unwavering support during a critical period in Ethiopia's history. As brotherly nations, Mexico also holds Ethiopia underground station in Mexico City and palm trees in the southern area of the City –a gift of emperor Haile Selassie to Mexico— as a symbol of our strong friendship.

While the Mexico Square" monument may no longer exist, the historical connection it symbolized continues to resonate in the bilateral relationship between Mexico and Ethiopia. It serves as a reminder of the enduring bonds of friendship, mutual respect, and shared values that unite the two countries. I would like to add that, even if the roundabout has suffered many changes, the Olmec head that was present and represented a gift from the people of Mexico to Ethiopia, can still be admired at the National Museum.

Today, the legacy of Mexico's support for Ethiopia's independence remains an important aspect of the bilateral relationship, contributing to a foundation of goodwill and cooperation.

### Capital: What are the main goals and priorities of the Mexican embassy in Ethiopia for the coming years, and how do you envision strengthening the bilateral relationship between the two countries?

Víctor Treviño Escudero: Cultural exchange and public diplomacy: Organize cultural events, art exhibitions, film screenings, and educational programs to showcase the richness and diversity of Mexican culture and heritage.

Deepen South-South cooperation in key industries: strengthen the dialogue between education institutes, businesses, and industries to find areas of opportunity that benefit both countries.

Promoting tourism and travel: Highlight tourist attractions, facilitate travel arrangements, and promote tourism packages and exchanges to encourage people-to-people connections and boost tourism revenues for both countries.

our artisans and, on a legal scope, to share with Ethiopia the efforts being made to protect traditional knowledge and cultural expressions and avoid cultural appropriation.

Capital: Ethiopia has made significant progress in recent years in areas such as infrastructure development and renewable energy. Are there any ongoing projects or opportunities for collaboration in these areas?

Víctor Treviño Escudero: Mexico has expertise in various aspects of infrastructure development, including transportation, energy, and telecommunications. Collaborative projects could involve sharing knowledge and best practices in infrastructure planning, financing, and implementation. This may include the construction of roads, bridges, airports, ports, and other critical infrastructure to support Ethiopia's economic growth and development goals.

Both Mexico and Ethiopia have vast renewable energy resources, including solar, wind, hydro, and geothermal

the overall stability of the Horn of Africa region. As one of the largest and most populous countries in the region, Ethiopia's internal stability has significant implications for neighboring countries. Mexico recognizes Ethiopia's efforts to maintain peace and stability domestically and sees its role as essential for preventing conflict spillover and fostering regional security.

Mediation and conflict resolution: Ethiopia has historically played a mediating role in regional conflicts and has been involved in peace efforts in countries such as South Sudan, Somalia, and Sudan. Mexico may view Ethiopia's mediation efforts positively and see opportunities for collaboration in supporting peaceful resolution of conflicts and promoting dialogue among regional actors.



Consular services and assistance: Providing consular services and assistance to Mexican nationals in Ethiopia and Ethiopian nationals in Mexico remains a core function of the embassy. Ensuring the well-being and safety of citizens, facilitating consular services, and promoting bilateral cooperation on consular matters are essential aspects of the embassy's work.

#### Capital: Any last words?

**Víctor Treviño Escudero:** Having lived in Ethiopia for 7 years, I have a great affection for its people and their fascinating history.

I see a great future for the Ethiopian People once they manage to resolve their internal conflicts and build a solid notion of unity between regions.

I leave very grateful for everything that I learned in this great country!

### **Public-Private** Partnerships in Healthcare

In the face of urgent healthcare financing needs, the adoption of public-private partnerships (PPPs) provides a viable opportunity to deliver healthcare service in Ethiopia. PPPs, characterized by their innovation and efficiency, hold the potential to ease government budgetary pressures while addressing the escalating demand for healthcare services.

Healthcare financing poses a serious challenge for developing countries. In 2001, African Union member states, under the Abuja Declaration, committed to allocate 15% of their national budgets to health. While Ethiopia has progressed in this front, increasing its health sector allocation to 10% of the total budget in 2021/22, it still falls short of the Abuja target. This gap underlines the ongoing challenge of meeting the committed funding and the need for additional measures to bridge the budgetary shortfall.

Ethiopia's Health Sector Transformation Plan II (2020/2021 - 2024/2025) foresees private sector involvement as a mechanism to mitigate the financing gap. One approach is to implement publicprivate partnerships (PPPs).

PPPs establish long-term partnership between the public and private sectors whereby a service or infrastructure ordinarily provided by the public sector is provided by the private sector with clear allocation of risks and responsibilities. In these partnerships, the private party assumes considerable risk and management duties. Unlike conventional procurement or outsourcing, PPPs transfer most of the risk associated with the design, construction, financing, operation, and maintenance of the infrastructure or service to the private sector. In return for an agreed output specification, the public sector compensates the private sector either through a fee-based structure or directly facilitating the establishment of clinics, hospitals, diagnostic and imaging centers, dialysis centers, and mobile health units in urban and rural communities. In addition, PPPs introduce private sector innovation, efficiency, and expertise, elevating the quality and range of healthcare services. This leads to better patient outcomes and satisfaction and results in the introduction of advanced technology and effective management practices that positively impact service delivery.

By leveraging private sector resources, PPPs hold the potential to optimize resource allocation and increase the cost-effectiveness and affordability of healthcare services. In countries like Ethiopia, where fees for public health services are set by law, the provision of high-quality private services at regulated prices offers significant advantages to the public.

Moreover, PPPs facilitate knowledge and skills transfer and capacity building. Through the integration of private sector services in public health systems, healthcare professionals in the public sector stand to gain immensely from the expertise, management practices, and technology-driven approaches of their private-sector counterparts. This exchange of knowledge and skills is instrumental in strengthening the capabilities of the health workforce, thereby enhancing the overall efficacy of the healthcare system.

While the advantages of PPPs in healthcare are substantial, implementing them comes with distinct challenges Foremost among these is maintaining a balance of interests between private and public stakeholders. Considering that the private sector assumes a significant portion of the financial risk, regulatory support and preparedness of the public sector is vital. Ethiopia laid the groundwork for PPPs with a PPP policy in 2017, complimented by the PPP Proclamation No. 1076/2018, PPP Directive No. 55/2018, and establishing a dedicated PPP Unit within the Ministry of Finance. While these arrangements form a solid foundation for the procurement of PPP projects, their effectiveness remains to be tested.

remains profitable to the private sector. In Ethiopia, as public healthcare fees are regulated by law (at a highly subsidized and non-cost-reflective rate), the project structure needs to consider how a PPP initiative would be attractive to the private sector. For this reason, strong government support by way of guarantee or availability payments needs to be arranged.

Ethiopia's governance structure also presents a distinct challenge while designing health PPPs. Successful health PPPs require the establishment of a robust, consistent, and reliable patient referral system, along with demand reliability. Navigating the intricacies of health sector governance both at the federal and regional levels under a centralized PPP framework poses unique challenges in project structuring and management of patient referrals. This, in turn, would require collaboration and commitment from the various public sector partners.

Ethiopia's public health insurance system, encompassing the Community Health Insurance Scheme and the Social Health Insurance Scheme, introduces added complexity to the design and implementation of health PPPs. As a significant contributor to healthcare service delivery, the public health insurance provider, i.e., the Ethiopian Health Insurance Service, is a key actor responsible for covering healthcare costs for insurance members. The payment terms to the private entity need to be aligned with the regulated fees and the intricacies of claim management of the insurance system.

PPPs introduce new approaches to work and service delivery within public institutions. Integrating the existing civil service workforce into the PPP initiative (which may involve the recruitment, transfer, or replacement of civil servants) necessitates alignment between the civil service rules and regulations and the labour legislations for private employers. PPPs for health service delivery offer a transformative opportunity for Ethiopia to address its multifaceted healthcare challenges. However, the successful implementation of PPPs in the health sector is contingent upon overcoming several challenges, including aligning the interests of public and private stakeholders, managing complex contractual and regulatory frameworks, ensuring equitable access, maintaining quality standards, and navigating the nuances of the health insurance system.

Given the significant public risk and the extensive institutional capabilities necessary for the successful deployment of PPPs, adopting a phased and flexible approach to implementation is prudent. This strategy allows for the careful assessment and management of risks at each stage, ensuring that lessons learned are integrated into future phases. Ethiopia can build the necessary institutional framework and capacity gradually, minimizing potential pitfalls while maximizing the benefits of PPPs. Such an approach not only facilitates more effective risk management but also enhances the adaptability and resilience of PPP projects, ensuring they align more closely with the evolving needs and capacities of the country.



Yet, in the past two decades, PPPs in social infrastructure projects such as health, education, housing, and waste management have taken root. The health sector has seen a notable increase in PPP usage. According to the Project Finance and Infrastructure Journal (IJGlobal), approximately 600 global healthcare infrastructure projects or assets, with a significant portion developed via PPPs.

Health PPPs hold the promise of addressing several challenges and making substantial contributions to healthcare systems. Key among these includes the potential to increase healthcare access,

### The African **Telecommunications Union** rallies for crisis connectivity solutions at global ministerial forum

### **TSIGIE GEBRESELAMA** CLINCHES VICTORY AT RAS AL KHAIMAH HALF MARATHON

n a spectacular showcase of athletic prowess, Tsigie Gebreselama emerged triumphant at the Ras Al Khaimah Half Marathon, a prestigious World Athletics Gold Label road race.

The Ethiopian athlete, renowned for her world cross country silver medal, shattered expectations by improving her personal best time by over half a minute, crossing the finish line in an impressive 1 hour, 5 minutes, and 14 seconds. Despite facing challenging weather conditions, including limited visibility of around 50 meters at the finish line, the elite athletes showcased exceptional resilience and determination throughout the competition.

Gebreselama's remarkable victory underscored her status as one of Ethiopia's most promising talents in long-distance running. After breaking away from the lead women's group alongside Yeshaneh, Gebreselama surged ahead in the final stretch, securing a welldeserved win.

Expressing her elation, the 23-year-old Gebreselama commented, "I am so happy to have run a personal best today." Reflecting on her strategy during the race, she added, "I was very worried about Peres (Jepchirchir) in this race, so I was surprised when she dropped back." Looking ahead, Gebreselama expressed ambitious goals, stating, "My aim is to break the half marathon world record."






